### E.F.T Authorization Agreement

Elysium Tennis membership includes access to a house charge account for service and Pro Shop purchases during the month. The Electronic Funds Transfer (EFT) system retains credit card information that is processed at the end of each billing period to pay the balance on this account. Charges will be posted as "Heil and Hornik LLC". I understand it is my responsibility to make sure that the credit card information listed on this agreement is current and valid. If, for any reason, the monthly charges are not accepted by the credit card company, I understand that a \$25 service charge will be added to my bill and I am responsible for full payment. **We impose a Flex Fee of 3% on credit card and \$.80 on ACH transactions, which is not greater than the cost of acceptance. Debit Cards are not subject to Flex Fees.**

## Conditions of Membership

---

1. **Change in type of Membership:** A member may change membership type by informing Elysium Tennis management by email. A 30-day notice is required. Membership type will be changed at the next billing cycle.
2. **Membership and Enrollment Fees:** Membership and Enrollment fees are non-refundable.
3. **Membership Renewal and Termination:** All members agree to abide by all policies, rules and procedures of Elysium Tennis, which are subject to change without notice. Membership will automatically renew annually. A member may terminate their membership with a 30-day notice by completing a Membership Termination Form at Elysium Tennis.
4. **Collection Fees:** There will be a \$25 administrative fee added to a member's account if payment of any form is returned for any reason.
5. **Payment:** All members must remain in good financial standing with Elysium Tennis. Staff will contact the member 3 times by phone or email. If the member fails to respond to staff efforts, the member's membership privileges will be suspended. Should a member's form of payment change, it is the responsibility of the member to notify Elysium Tennis upon change.
6. **Guest Policy:** Members may bring a non-member guest up to 3 times per calendar year.
7. **Cancellation Policy:** Elysium Tennis requires a 24-hour notice when canceling a reservation for courts, lessons and clinics. Members will be charged the appropriate fee if sufficient notice is not provided for cancellation.
8. **Change of Address and Communication:** Members must notify Elysium Tennis of any email, address, phone or name changes.
9. **Health Warranty:** Each member represents to Elysium Tennis that he/she is physically fit to perform all those activities which he/she undertakes at Elysium Tennis and that he/she understands all the health risks associated with such activities.
